

#### | Nature of the tasks:

The Unit "Electronic Communications Policy" develops policy and legislation in the field of electronic communications. By coordinating the review of the telecoms regulatory framework the Unit is the focal point for completing one of the key initiatives of the Digital Single Market Strategy. The remit of the unit covers various aspects of electronic communications policy ranging from network access and competition aspects to security and numbering as well as various consumer issues including net neutrality, switching and universal service. While the successful completion of the European Electronic Communications Code is the short-term priority, the unit will naturally follow closely the implementation of the new framework, and be involved in preparing relevant secondary legislation and guidance. 

#### 1 Nature of the tasks:

The expert will be part of the Unit in charge of the marine environment and water industry policy (covering drinking water (98/83/CE), bathing water (2006/7/CE) and urban waste water treatment (91/271/CEE)) of the EU.

### 1 Nature of the tasks:

The Securities Market unit is responsible for: (1) the operation of investment firms; (2) stock exchanges; (3) alternative trading platforms for stock and derivatives; (4) the prevention of market abuse; (5) the regulation of financial benchmarks and (6) the public offer and admission prospectuses.

The Unit is also actively involved in the review of the prudential framework for Investment Firms and in the review of the European Supervisory Authorities Regulation that are both currently pending before the colegislators and, in that capacity, regularly participates in Council Working Groups, as well as engages with the European Parliament.

In addition, the Unit is in charge of the ongoing equivalence assessments of third country rules for trading venues under the Markets in Financial Instruments Regulation.
