### 4.2 Quality and importance

Representa uno de los escasos islotes que conservan restos de vegetación autóctona en una zona de gran uniformidad, al haber sido transformada por los usos agrarios. Se caracteriza por la singularidad de algunas de las especies botánicas que alberga. Las principales singularidades aparecen sobre todo en las formaciones rupícolas de las paredes rocosas del peñón y en la vegetación de ribera del arroyo de Malaspasadas y río Guadalporcún. La Reserva Natural destaca, sobre todo, como enclave faunístico

excepcional, debido al hecho de albergar la mayor colonia nidificante de buitre leonado de Andalucía Occidental. A todo ello hay que unir la presencia, permanente u ocasional, de otras especies faunísticas de gran interés como el águila perdicera, el alimoche, el búho real y el halcón común.
