4.2 Quality and importance

Isla situada en el centro del Mar de Alborán, a algo menos de 55 millas nauticas de la costa almeriense de origen volcánico, y reducidas dimensiones (600 metros de larga por 280 metros en su parte más ancha) en

la misma desde el punto de vista florístico es de destacar la presencia de varios endemismos entre los que sobresale *Diplotaxis siettiana*. A nivel faunístico se han catalogado diversos endemismos, siendo este el único enclave andaluz donde nidifican la Gaviota de Audouin (*Larus audouinii*). En su extensa plataforma marina confluyen las corrientes de aguas atlánticas que penetran en el Mediterráneo a través del Estrecho de Gibraltar, ello posibilita la aparición de elementos representativos del Atlántico. La comunidad algar constituye extensas praderas de Laminarias en las que aparecen las dos especies *Laminaria ochroleuca* y *Saccorhiza polyschides*. Así mismo son de destacar las formaciones de coral rojo (*Coralium rubrum*).
