4.2 Quality and importance

Imprescindible para el hábitat 2270 de la Directiva 92/43/CEE. Presencia de *Carduus myriacanthus*. Las comunidades vegetales existentes son el resultado de la intervención humana (repoblación de *Pinus pinea*). Al ser paso obligado de avifauna en las rutas migratorias el espacio es excepcional para aves. vegetación marina típica de estas costas. En cuanto a aves la importancia le viene dada por la numerosa colonia de Garcilla Bueyera (*Bubulcus ibis*), que se reproduce en los acantilados.
