RESOLUTION OF 3, 2015 FOR TALENT HUB FELLOWSHIPS IN ACCORDANCE WITH THE REGULATIONS OF ORDER OF JULY 24, 2014 OF THE REGIONAL MINISTRY OF ECONOMY, INNOVATION, SCIENCE AND EMPLOYMENT ESTABLISHING THE RULES AND FOUNDATIONS OF THE TALENT HUB FELLOWSHIP PROGRAM FOR TRANSNATIONAL MOBILITY OF RESEARCHERS.

In view of the applications received for the Talent Hub Fellowship Call governed by the Regulations of Order of July 24, 2014 of the Regional Ministry of Economy, Innovation, Science and Employment establishing the rules and foundations of the Talent Hub Fellowship Program for transnational mobility of researchers, published in the Official Gazette number 148 of July 31, 2014, we present the following

BACKGROUND FACTS

1. By Order of July 24, 2014 the rules and foundations of the Talent Hub Fellowship Program are established and the First Call for Applications of the Talent Hub Fellowship Program is issued.
2. Applications have been received within the deadline and presented in the manner required in the Order of July 24, 2014. Procedures have been developed in accordance with the provisions of Article 16 of the Order.
3. On November 10, 2014 a Resolution declaring applications not admitted (3) was published.
4. The Committee has been appointed as provided in paragraph 13 of the Call Summary of the Order of July 24, 2014. The Selection Committee has reviewed and evaluated the applications taking into account the criteria contained in section 12 of the Call Summary.
5. The Selection Committee of the Talent Hub Program met in Cordoba on November 25, 26 and 27th and has drafted its provisional outcome including nomination of the provisional beneficiaries and candidates on the reserve list for each mobility scheme and of the applicants that did not pass the evaluation process.
6. The result was published in the Provisional resolution proposal of December 16, 2014 and candidates were informed they will have a period of 10 days to present Annex II as established in Article 17 of the Order of July 24, 2014.
7. As of January 14, 2015 an amendment to the Provisional resolution proposal of December 16, 2014 was published listing the candidates in order of marking (descending punctuation) instead of ranking the candidates on the reserve list in alphabetical order.
8. Concluded as of December 29, 2014 the period for submitting form-annex II for redress, acceptance, redrafting and submission of documents, and as established in articles 18 and 19 of the Order of July 24, 2014, the relevant bodies analyzed the redress requests, verified documents submitted and elaborated Final Outcome proposal.

As a result of the above facts the following applies

LEGAL FOUNDATION

1. In accordance with paragraph 4 of Article 17 of the Order of July 24, 2014 lack of presentation of the required documents of the Provisional Outcome before its deadline entails withdrawal of the application in case of accreditation requirements and modification of the assessment made in case of evaluation criteria.
2. In accordance with paragraph 8 of the Final Regulation of the Order of July 24, 2014, the number of candidates on the reserve list is limited to 10 under each mobility scheme.

3. Evaluation and selection was conducted by the relevant bodies as established in paragraph 13 of the Call Summary of the Order of July 24, 2014:
 - a) The Selection Committee is the competent body to process the evaluation of the applications and draft the provisional outcome through the relevant minutes of its sessions and evaluation reports.
 - b) The General Secretariat of the Andalusian Knowledge Agency is the managing body, in charge of revision of redress requests, documents submitted and eligibility criteria.
 - c) The Managing Directorate of the Andalusian Knowledge Agency is the entitled body to determine the outcome as described in article 115 of the revised text of the General Finance Law of the Junta de Andalucía.

As a result of the above, following proposal by the General Secretariat and according to the articles 13 of the Call Summary and article 15 of the Order of July 24, 2014 and on behalf of the vacant position of the Managing Direction at the AAC (Article 13.3 of Decree 92/2011 of April 19, approving the Statutes of the AAC, Official Gazette number 83 of April 29, 2011) I hereby issue

RESOLUTION

1. Talent Hub Fellowships are awarded to the 30 candidates listed in Annex I of this resolution, where it is detailed: research project object of the award, contracting and host entities, mobility scheme, start date, and detail of the granted amounts in total and as itemized by concepts.
2. Candidates listed in Annex II are declared in the reserve list, and could become beneficiaries in the listed order in case the awardees do not accept or reject their awards, provided conditions and deadlines established for the call could be maintained.
3. Candidates that did not pass the evaluation process as foreseen in the Order of July 24, 2014 are listed in Annex III.
4. The research activities will last 24 months and will start not later than March 1, 2015.
5. Prior to the start of the activities:
 - a) Contracting entities who signed Annex IV to Order of July 24, 2014 must sign Agreement with Andalusian Knowledge Agency complying with Annex V of the mentioned Order.
 - b) Host entities who signed Annex III, as well as contracting entities who signed Annex IV, regarding the period they will act as host entities, should provide ethics report according to the ethical rules applying to the European Union Seventh Framework Programme for Research (Decision 2006/1982/EC of the European Parliament and the Council of December 18, 2006).
6. The program OP05010203, PROJECT CODE 2014000205, of service 13 "other European Funds" and budget application 0.1.11.00.13.00. .740.23.54A is financed by:
 - a) The Junta de Andalucía (60%) for an amount of 5.623.921 euro.
 - b) The European Union (40%) through the Grant Agreement number 291780 of EU 7th Framework Programme via the Marie Curie Action, "Co-funding of Regional, National and International Programs" for an amount of 3.749.281 euro.
7. The planned expenditure is 4.756.208 euros, distributed annually as follows:

8. The funds will be transferred to the collaborating entities that will hire the researchers as foreseen in the Order of July 24, 2014 once they have signed the Agreement complying to Annex V.
9. The payment method will be anticipated by a maximum of 75% of the funds, through quarterly advances of 12,5% of the total Fellowship as established in paragraph 24.b) of the Call Summary of the Order of July 24, 2014.
10. In accordance of paragraph 8.g) of the Call Summary of the Order of July 24, 2014, the collaborating entities must fulfill the following criteria:
 - a) Be a knowledge generation agent of the Andalusian Knowledge System, essentially universities and public research institutions in Andalucía. (Law 16/2007, December 3, Science and Knowledge Act and Decree 254/2009, of May 26).
 - b) Be aggregated in Campus of International Excellence based in Andalusia.
 - c) Meet the requirements set by paragraph 2.2.d) of the Community Framework for State Aid for Research, Development and Innovation (2006/C 323/01) to be considered as a Research Institute: a body such as university or research institute, irrespective of its legal status (organized under public or private law) or way of financing, whose primary goal is to conduct fundamental research, industrial research or experimental development and to disseminate their results by way of teaching, publication or technology transfer; all profits are reinvested in these activities, the dissemination of their results or teaching; undertakings that can exert influence upon such an entity, in the quality of, for example, shareholders or members, shall enjoy no preferential access to the research capacities of such an entity or to the research results generated by it.
11. According to section 8.g) of the Call Summary of the Order of July 24, 2014, the obligations of the contracting entities are:
 - a) Establish a working relationship with the beneficiaries in accordance with the provisions of these regulations.
 - b) Pass the funds received to the beneficiaries according to the regulations.
 - c) Report on the economic incentive.
 - d) Commit to the principles of the European Charter for Researchers and The Code of Conduct for the Recruitment of Researchers.
 - e) In line with the rationale and principles of the People Program within the FP7, the Research Project will be approved by an ethical review board. The ethical review board will verify that the Project complies with their destination's national and regional regulations regarding ethics, as well as with the limitations imposed by the ethical rules applying to the EU's Seventh Framework Programme for Research. Prior to the signing of the contract it will be reviewed by the Ethics Committee. The ethical aspects of the research project will be subjected to specific monitoring along the project (Decision 2006/1982/EC of the European Parliament and the Council of December 18, 2006).  - f) Adhere to all monitoring and control of the Research Project by Junta de Andalucía and the European Union.
 - g) Collaborate in the procedure of refund when the case is given.
 - h) Allow verification and control processes by Andalusian Agency of Knowledge, European Union as well as by any other competent institution, providing requested information.
 - i) Return funding in the event requirements and obligations are not fulfilled, and, in any case, according to article 37 of Law 38/2003, of November 17, General Grants.
12. Additionally, beneficiaries should comply with relevant obligations stated in article 24 of the Order of July 24, 2014.

13. According to section 26 of the Call Summary of the Order of July 24, 2014, reporting to Andalusian Knowledge Agency:
 - a) Will be made by the contracting entities.
 - b) Deadlines for reporting of transfers to contacting entities will be those established in section 24.b) of the Call Summary of the Order of July 24, 2014, one month after each period of three months.
 - c) Equally, according to section 26.b) of the Call Summary of the Order of July 24, 2014, final deadline for reporting after the end of the research project will be three months.
 - d) The content of the reports will be the established at section 26.f).1.º of the Call Summary of the Order.
 - e) Documents should be originals or certified copies.
14. According to article 21 of the Order of July 24, 2014, and section 19 of the Call Summary, this resolution will be published in the websites of Consejería de Economía, Innovación, Ciencia y Empleo www.juntadeandalucia.es/economaiinnovacioncienciayempleo/ and Agencia Andaluza del Conocimiento www.aac.es. Publishing substitutes personal notification at all effects.
15. This resolution ends the administrative procedure. Against it can be executed right of appeal according to Law 29/1998, of 13 July or according to Law 30/1992, of 26 November.
