Other Site Characteristics

A pesar de la existencia de la presa de Los Melonares y su efecto negativo sobre la continuidad ecológica, el espacio mantiene una función como corredor ecológico aéreo a través de las aves ligadas a los ambientes acuáticos que lo frecuentan, como es el caso de la cigüeña negra que visita el espacio protegido en sus movimientos de campeo.

4.2 Quality and importance

Espacio importante por la existencia de fresnedas que constitiyen el hábitat de interés comunitario 91B0: Fresnedas termófilas de Fraxinus angustifolia (Directiva 92/43/CEE), considerado muy raro en Andalucía. Respecto a la fauna, destaca especialmente la presencia del odonato Coenagrion mercuriale, así como de Lutra lutra.
