Other Site Characteristics

La ZEC Rivera de Cala pertenece a la subcuenca Rivera de Huelva. Geológicamente se caracteriza por discurrir sobre colinas y cerros en rocas y el río discurre sobre suelos del tipo regosoles y cambisoles éutricos y litosoles con rankers. El lugar queda encuadrado principalmente en la categoría paisajística Serranías, dentro del áreapaisajística Serranías de baja montaña. La vegetación potencial que se presenta es la que corresponde a la serie EH7: geoserie edafohigrófila meso-termomediterráneamediterráneo-iberoatlántica silicícola. En la primera banda de la ZEC Rivera de Cala dominan los adelfares o baladrales.

4.2 Quality and importance

Importante por sus clases de hábitat bien conservados que favorece la existencia de diversidad de anfibios, alguno especie endémica de la península ibérica.Se han incluido dos especies presentes en la Lista Roja de la Flora Vascular de Andalucía: Gratiola linifolia y Gratiola officinalis. De igual modo, se incluye la especie Allium schmitzii, la cual es una especie de reciente descubrimiento en Andalucía donde sólo se conocen dos poblaciones.
