Other Site Characteristics

Desde el punto de vista morfogenético, destacan las formas de origen fluvio-coluvial, generadas por procesos de erosión-acumulación causados por la red hidrográfica, dando lugar a morfologías muy características en las que predominan las llanuras y planos inclinados. Las fisiografías de vegas y llanuras de inundación, vinculadas a los cursos de los ríos y arroyos, son las más representativas. También es importante el sistema morfogenético denudativo (colinas y cerros sobre trías con yesos).

4.2 Quality and importance

Importante para Rutilus alburnoides. se confirma la presencia de Laurus nobilis, incluida en el Listado Andaluz de Especies Silvestres en Régimen de Protección Especial y Nepeta apuleii, incluida en la en la Lista Roja de la Flora Vascular de Andalucía.
