- Lead parent-carer meetings
- Do morning circle and leads activity days
- Plan weekly activities and monthly themes
- Care for the children
- Prepare meals
- Maintain the daycare



We are inspired by the Educaring approach by Magda Gerber and we hope that you are familiar to this approach. You must be fluent and confident in speaking, as well as writing, in English. A knowledge of the Finnish language is a plus.

Your Degree must already be recognized by Finnish National Agency for Education (OPH), or on process already, before starting employment with us. The manager/owner will help you with the process. The manager/owner will also help you with administrative processes when moving to Finland such as getting a tax card and opening a bank account. You will be provided with links to housing rental companies. Please note that a criminal record from the Finnish police must be presented (required by the law) and we will help you with the process.

LTI follows the regulation of 1:4 / 1:7 (adult:child ratio). You will work with another educator. You are entitled to paid holidays according to the Annual Holiday Law in Finland. LTI provides all the mandatory insurances for its employees. LTI adheres to the guidelines of the collective agreement for private social services sector (SOSTES).

You will be given time-off from work to open your bank account and get your tax card. You will be provided with links to housing rental companies as well as links to OPH. The owner / manager is always ready to assist you and answer any of your queries, if you need more help or guidance in any matter relating to your employment and residence here in Finland.
